

WAIVER AND RELEASE OF LIABILITY

THIS AGREEMENT is entered into by and between BACK ROAD BOARDING and _____ ("OWNER"):

1. By enrolling the above named and described dog(s), I represent that I am the legal owner of the named dog(s) and I assume all risks, dangers and responsibility for injuries to the named dog(s). Owner understands and agrees that Owner is solely responsible for any harm to Owner's dog(s) while Owner's dog(s) is/are attending BACK ROAD BOARDING.

2. Boarding extremely old, chronically ill or otherwise debilitated pets requires extra care, which we are happy to provide. However, special-needs pets, puppies and senior pets naturally have a higher risk of injury, stress-related illness, or exacerbation of any pre-existing condition. As such, by boarding your special- needs pet, puppy or senior pet with us you are waiving any claim for injury or illness experienced by your pet while in our care and that is not directly caused by negligence or lack of care on our part. _____ (initials)
3. Owner understands and agrees that during normal dog play. Owner's dog may sustain injuries. All dog play is monitored to avoid injury, but scratches, punctures, torn ligaments, and other injuries may occur despite the best supervision. _____ (initials)
4. No dogs that show signs of aggression will be allowed to play in play yard with others. Owner further understands and agrees that in admitting Owner's dog(s) to BACK ROAD BOARDING, Owner is representing to BACK ROAD BOARDING that Owners dog(s) is/are in good health and have not harmed, shown aggression, or exhibited any threatening behavior toward any person or other dog .This pertains to if Owner is enrolling their dog(s) in either daycare or overnight stay. _____ (initials)
5. Owner further understands sand agrees that neither BACK ROAD BOARDING nor any of its staff or volunteers, will be liable for any illness, injury, death and/or escape of Owner's dog(s) providing that reasonable care and precautions are followed, and Owner herby releases all of them

of any liability of any kind whatsoever arising from or as a result of Owner's dog(s) attending or participating at BACK ROAD BOARDING.

6. Owner further understands and agrees that any behavioral or physical health problems that develop with the Owner's dog(s) while at BACK ROAD BOARDING will be handled and treated as deemed best by the staff or volunteers of BACK ROAD BOARDING, in their sole discretion, and Owner expressly agrees to assume full financial responsibility for any and all expenses arising or relating thereto. This includes aggressive or destructive behavior. _____ (initials)
7. Owner further understands and agrees that Owner's dog(s) are healthy and will at all times while attending BACK ROAD BOARDING have current vaccinations. Owner is not enrolling any dog that has any condition that could potentially jeopardize the health of other dogs or people and has not had any potentially communicable condition within 30 days prior to enrollment. Owner further understands that even if Owner(s) dog is vaccinated for Bordetella (Kennel Cough) there is a chance that the Owner(s) dog can still contract Kennel Cough. I agree that I will NOT hold BACK ROAD BOARDING responsible if Owner's dog(s) contracts Kennel Cough. _____ (initials)
8. Owner further understands and agrees that it is the Owner's responsibility to leave an adequate supply of food and medications for Owner's dog(s) during the entire time Owner's dog(s) is cared for by BACK ROAD BOARDING. Should the food/medication supply need replacement, I authorize BACK ROAD BOARDING to purchase replacement and Owner will reimburse BACK ROAD BOARDING for the cost plus a \$20.00 replacement fee(per occurrence) plus the actual food and medication costs. Should a dog be observed to have fleas or ticks while attending BACK ROAD BOARDING a treatment will be applied and charged to the owner at a minimum rate of \$20.00. _____ (initial)
9. Owner further understands and agrees that Owner(s) dog(s) will have access to fenced outside play area. Owner(s) agree to assume full liability if Owner(s) dog(s) escapes _____ (initial)
10. Owner further understands and agrees that if Owner's dog(s) is/are not picked up by the end of the BACK ROAD BOARDING regular business day,

then Owner hereby expressly authorizes BACK ROAD BOARDING to take whatever action is deemed necessary for the continuing care of Owner's dog(s) and Owner agrees and promises to pay to BACK ROAD BOARDING all costs of continuing such care upon demand by BACK ROAD BOARDING. Further, Owner understands that if Owner does not pick up Owner's dog(s) as scheduled, BACK ROAD BOARDING shall be authorized to proceed according to the local municipal code governing abandonment of animals. _____ (initial)

11. Owner further understands and expressly agrees that each and every of the foregoing provisions in Paragraphs 1-10 above shall be in force and effect and shall apply to each and every occasion on which Owner boards or deposits Owner's dog(s) with BACK ROAD BOARDING as the case may be. This Agreement shall remain in full force and effect as between the parties until and unless otherwise cancelled or superseded by a writing signed by both parties. _____ (initial)
